REGULATIONS OF THE ART COMPETITION "THE 2ND EDITION OF THE POWIŚLAŃSKI UNIVERSITY ART COMPETITION".

I. General Provisions:

1. The Regulations establish the terms and conditions for the organization of the Artistic Competition

" II EDITION OF THE ARTISTIC CONTEST OF THE Powiślański University "(hereinafter: "Contest").

- The Organizer of the Contest is Powiślański University, headquartered in: 82-500 Kwidzyn, ul. 11 Listopada 29 (hereinafter: "Organizer").
- 3. The purpose of the Contest is to promote photographic documentation showing medical professions and landscapes - taken by Students of Powiślański University/its employees (hereinafter referred to as: "Participants") participating in the contest, as well as to include the awarded and honored photos in the Organizer's collection.

with preservation of the Participants' personal copyrights.

- 4. The contest is organized as part of the International Week'24 event implemented by Powiślański University.
- 5. Each Participant of the Contest by entering this Contest agrees to the provisions and undertakes to comply with these Regulations.
- 6. The contest begins on 24.04.2024 and lasts until 19 .05.2024.
- 7. The Organizer reserves the right to extend the duration of the Contest beyond the deadline specified in paragraph 6, of which it will inform the Contest Participants, among others, via the website/e-mail.
- 8. The territory of execution of works for the Contest by Participants is the territory of Poland.
- 9. The contest is open to students of Powiślański University, teaching and administrative staff of the University as well as registered participants of the International Week'24 event.
- 10. The Regulations of the Contest (hereinafter referred to as "Regulations") are available at the Organizer's office and on the Organizer's website (www.powislanska.edu.pl).

II. Applications:

- 1. The subject of the Art Contest "II EDITION OF THE ART CONTEST OF THE Powiślański University" is the photographs submitted by the Participant.
- 2. The competition is organized in the following thematic categories:
 - a) The beauty of the landscape,
 - b) The beauty of the competition.
- 3. Each Participant may submit one entry to the contest. The work in photographic form can contain a maximum of 10 photos in any categories (all photos can be of one subject or different).
- 4. The themes of the submitted works/competition works must be related to directly related to:
 - a) The beauty of the landscape- may include, among other things, still life as well as living nature In the form of photographs,
 - b) The beauty of professions-may include, among others, professions involving specialized dress in the form of photography.
- 5. Submission of the competition work should be made by submitting the work in electronic form to the e-mail address: konkurs@powislanska.edu.pl.
- 6. Each work submitted to the Competition must bear the name of the author. In addition, the entry must indicate the category for which it is submitted, the date and place of execution and a description. The author may (not necessarily) title the submitted works (the Organizer reserves the right to change the title). Contact information e-mail, telephone number should also be indicated. In the case of students, the work should also bear the direction and year of study, and in the case of employees, the position held.
- 7. In order to qualify the Participant's submitted application, it is necessary to include all the elements listed in point. 6 elements and:
 - a) photographs must be saved as digital files (JPG file format with maximum quality, minimum size of the longer side 3500 pixels, resolution 300 dpi), the names of which should consist of of the author's surname and first name (without Polish characters) and the subsequent number of the photograph according to the scheme "surname_name1.jpg",
 - b) if the files of works in photographic form weigh more MB than the capacity of a single email, you can send the files in several separate ones, clearly indicating this in the description and title of the emails or using **wetransfer.com**,
- 8. Submitted works must not have been previously awarded or published as part of other competitions.

III. Participants and entry to the Competition:

Students of Powiślański University at all locations and administrative and teaching staff as well as registered participants in the International Week'24 event.

IV. Copyright:

- 1. The contest is voluntary, and entering the contest is tantamount to consenting to for the processing of personal data by the Organizer for the purposes of the contest.
- 2. By entering the Competition the participant agrees to present the work in the post-competition exhibition, as well as on the Internet, including on the university's subject page and on the university's Social Media, along with the name, surname, the vear in which the photo was selected/participated in the competition and the title of the photo

As well as to publicize the place of education.

V. Evaluation by the jury of the Competition:

- 1. The submitted works will be judged by an appointed Competition Commission, which will be represented by a representative of the University Authorities (Rector/Prorector), a representative of the staff of the Information and Marketing Department, a representative of the Student Government (selected by the Government).
- 2. In evaluating the work, the Competition Commission adopts the following criteria for evaluating the competition works:
 - a) Compatibility with the theme beauty of the landscape / beauty of the professions,
 - b) originality of the work,
 - c) innovation of work,
 - d) level of creative freedom.

VI. Awards:

- There will be prizes for the winners and authors of awarded works. In both categories the Organizer provides: I, II and III place as well as each 3 honorable mentions per category. A total of 6 main prizes and 6 honorable mentions.
 - 1) The grand prizes include:
 - a) Gift Cards,
 - b) A large set of gadgets,

- c) Diploma/award.
- 2) For distinctions:
 - a) A small set of gadgets,
 - b) Diploma/award.
- 2. The announcement of the winners of the 2nd Edition of the Powiślański University Art Contest as well as the presentation of awards will take place during the Faces of Prosperity Conference on May 25, 2024.
- 3. In addition, the works of the grand prize winners will be placed displayed/positioned in the lobby of the university, including locations: Kwidzyn, Gdansk, Koscierzyna for up to 3 years from the date of their selection. Each disseminated work will have the name of the author, the year in which the competition took place and the title of the work.

VII. Final Provisions:

- 1. Any doubts regarding the rules of the Contest, provisions of its Regulations and interpretation shall be resolved by the Organizer.
- 2. The winner of the prize will be notified by e-mail within 3 (three) days after the end of the Contest edition in a given month, to the e-mail address he/she indicated during the Contest.
- 3. In order to confirm the will to accept the prize, the notified Conqueror should respond by e-mail to the address indicated by the Organizer within 3 (three) days from the date of sending the notification, under pain of losing the right to the prize.
- 4. Senate Representative for Institutional Cooperation Julia Osuch, MA, will be responsible for handing over the prizes to the winners.
- 5. The Organizer is entitled to change the provisions of these Regulations, as long as it does not worsen the conditions of participation in the Contest. This applies, in particular, to changes in the deadlines of individual Contest activities and changes in prize specifications. The amended Regulations are effective from the time they are published on the site.
