

**Resolution No. 9/VI/25/S**  
**of the Senate of Powiślański University**  
**dated June 13, 2025**  
**on the adoption of amendments to the admission rules for the academic year 2025/2026**

Pursuant to Articles 69 and 70 of the Act of 20 July 2018 – Law on Higher Education and Science (Journal of Laws 2024, item 1571), the Statute of Powiślański University (§16, item 6), and the Study Regulations of Powiślański University, the Senate of Powiślański University hereby resolves to amend Annex No. 1 to Senate Resolution No. 6/VI/24/S of 24 June 2024 on the adoption of the Admission Rules to Powiślański University for the academic year 2025/2026 (applicable to candidates for first- and second-cycle degree programmes, including those without Polish citizenship), in accordance with the following provisions:

**§ 1**

In Annex No. 1 to Resolution No. 6/VI/24/S of the Senate of Powiślański University of Applied Sciences dated June 24, 2024, on the adoption of the Admission Rules to Powiślański University of Applied Sciences for the academic year 2025/2026 (applicable to candidates for first- and second-cycle degree programmes, including those without Polish citizenship), the following amendments are introduced:

- 1) § 2(5) shall now read as follows: “In the case of a minor candidate who is under the age of 18 at the time of enrollment, an additional document must be submitted — a declaration (template in accordance with University guidelines), in which the legal representative (parent/legal guardian/proxy) confirms their consent for the minor to commence studies. Based on this document, the underage candidate is permitted to sign documents required during the admission process. The signature of the legal representative on the declaration must be certified by a notary or by an authorized institution competent for signature authentication in the respective country.”
- 2) § 4(1) is renumbered as § 4(3).
- 3) § 4(2) is renumbered as § 4(4).
- 4) § 4(3) is renumbered as § 4(5).
- 5) § 4(4) is renumbered as § 4(6).
- 6) § 4(5) is renumbered as § 4(7).
- 7) § 4(6) is renumbered as § 4(8).
- 8) § 4(7) is renumbered as § 4(9).
- 9) As a result of the changes referred to in items 2–8 above, § 4(1) in Annex No. 1 to Resolution No. 6/VI/24/S of the Senate of Powiślański University of Applied Sciences dated June 24, 2024, shall now read:  
“A candidate for studies at Powiślański University of Applied Sciences who does not hold Polish citizenship must possess language competencies that enable them to complete the admission process and to undertake education in the chosen field of study.”
- 10) As a result of the changes referred to in items 2–8 above, § 4(2) in the same Annex shall now read:  
“A candidate referred to in paragraph 1 is required to present, during the admission process, a document confirming their proficiency in the language of instruction for the selected degree programme (field, level, and profile), at a proficiency level specified in Article 10(5) of the Act of April 4, 2025, amending certain acts to eliminate irregularities in the visa system of the Republic of Poland (Journal of Laws 2025, item 622). The University shall verify the language competencies referred to in paragraph 1 based on the document submitted by the foreign national during the admission process, confirming proficiency in:  
  - a) the Polish language — if the programme is delivered in Polish,
  - b) a foreign language — if the programme is delivered in a foreign language,- at the established proficiency level referred to in Article 10(3)(b) of the aforementioned Act.”
- 11) § 5(2)(c) shall now read as follows:

“For candidates applying for admission to first-cycle studies:

- a document issued abroad by a school or educational institution recognized by the state in which it operates or within whose educational system it functions, together with a written statement from the Director of NAWA confirming the holder’s eligibility to apply for admission to higher education, or
- a written statement from the Director of NAWA confirming the holder’s eligibility to apply for admission to higher education — in cases referred to in Article 93a of the Act of September 7, 1991, on the Education System.”

12) § 5(2)(d) is added and shall read as follows:

“For candidates applying for admission to second-cycle studies:

- in the case of a diploma subject to nostrification in accordance with applicable legal regulations — a certificate issued by the institution conducting nostrification confirming the equivalency of the foreign diploma with a Polish higher education diploma;
- a copy of documents enabling assessment of the course and duration of studies, e.g., diploma supplement, list of subjects and grades, academic transcript, or other relevant documents;
- a diploma of higher education issued abroad by a university recognized by the state in which it operates or within whose higher education system it functions, together with a written statement from the Director of NAWA confirming the holder’s eligibility to apply for admission to second-cycle studies.”

13) § 5(5)(a) shall now read:

“A certificate listed in the catalogue of certificates referred to in Article 10(3)(b) of the Act of April 4, 2025, amending certain acts to eliminate irregularities in the visa system of the Republic of Poland (Journal of Laws 2025, item 622).”

## § 2

1. In Annex No. 1 to the Admission Rules to Powiślański University for the academic year 2025/2026 (applicable to candidates for first- and second-cycle studies, including those without Polish citizenship), the description of expected competences from the candidate for all fields of study is amended as follows:

1) For fields of study conducted in Polish, it shall read:

"according to § 4 section 3 of the Admission Rules to Powiślański University for the academic year 2025/2026".

2) For fields of study conducted in English, it shall read:

"according to § 4 sections 1, 2, and 3 of the Admission Rules to Powiślański University for the academic year 2025/2026".

2. In Annex No. 1 to the Admission Rules to Powiślański University for the academic year 2025/2026 (applicable to candidates for first- and second-cycle studies, including those without Polish citizenship), the following detailed admission requirements for the first-cycle studies in the field of Economics conducted in English are added:

**Field of study:** Economics

**Level:** First-cycle studies conducted in English

**Mode:** Part-time

<b>Secondary school certificate subjects considered in the admission process:</b>	In accordance with Annex No. 3 to the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Expected competences from the candidate:</b>	In accordance with § 4 sections 1, 2, and 3 of the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Remarks:</b>	Language competence at a level compliant with § 4 sections 1 and 2

3. In Annex No. 1 to the Admission Rules to Powiślański University for the academic year 2025/2026 (applicable to candidates for first- and second-cycle studies, including those without Polish citizenship), the following detailed admission requirements for the second-cycle studies in the field of Nursing conducted in English are added:

**Field of study:** Nursing

**Level:** Second-cycle studies conducted in English

**Mode:** Part-time

<b>Secondary school certificate subjects considered in the admission process:</b>	In accordance with Annex No. 3 to the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Expected competences from the candidate:</b>	In accordance with § 4 sections 1, 2, and 3 of the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Remarks:</b>	Medical certificate issued by an occupational medicine physician confirming no contraindications for undertaking studies; language competence at a level compliant with § 4 sections 1 and 2

4. In Annex No. 1 to the Admission Rules to Powiślański University for the academic year 2025/2026 (applicable to candidates for first- and second-cycle studies, including those without Polish citizenship), the detailed admission requirements for the first-cycle studies in the field of Nursing conducted in English are amended as follows:

**Field of study:** Nursing

**Level:** First-cycle studies conducted in English

**Mode:** Full-time

<b>Secondary school certificate subjects considered in the admission process:</b>	In accordance with Annex No. 3 to the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Expected competences from the candidate:</b>	In accordance with § 4 sections 1, 2, and 3 of the Admission Rules to Powiślański University for the academic year 2025/2026
<b>Remarks:</b>	Medical certificate issued by an occupational medicine physician confirming no contraindications for undertaking studies; language competence at a level compliant with § 4 sections 1 and 2

### § 3
